# **Woodley Detached report August 2015**



# We have appointed Fiona Adamson as our new Woodley Team Leader

She has completed training and induction and has been getting to know the detached team throughout the summer.

Fiona has vast experience in building supportive relationships with young people across the age range, including those with complex needs. We are very lucky to have her and are sure that she will bring a fresh impact to our work in Woodley.

Over the summer holidays we took a group to Southbourne for a day out including fun on the beach and a BBQ in the evening. Detached sessions continue to run throughout the holidays. Sessions at Vauxhall Park are continuing (where groups sometimes gather); Woodford Park becomes quiet from 8:30 or 9 onwards (as people leave the skate park area) and the precinct is more popular later on. Groups gather at Tesco but there is no regular pattern to this and occasionally a small group use the alcove at the library by the car park.

We have been talking to young people about renovating the shelter and there are a few groups who would be happy to help with this. We have made it clear that there are no funds but we have asked young people for their suggestions regarding the ground underneath the A329M bridges. Suggestions so far: BMX, free running area (put up obstacles and people run through them), outdoor cinema - where they could project the film onto the supports of the A329M bridge.

# **Training & Staff**

Due to the fact that we had a waiting list for most of last year and the increase in demand for our services – we have recruited one full time and one part time Equine Youth Worker who will run sessions at our stables. They have received training and induction over the summer and will be a great asset to our team. We also have 3 new sessional staff who will undertake mentoring with our young people.

**Mentoring** sessions continue to take place weekly, in the community, and at Rehoboth. We are still working with other key agencies on complex cases and family issues.

**Equine sessions:** Over the summer holiday we had groups of young people volunteering most days (6 days per week). Young people have been covering staff and other volunteers' holidays to ensure the animals are looked after. We ran a volunteer fun day at the stables for all our volunteers last week, as a celebration to thank them for their commitment and time. The Woodley Schools have booked back in for the autumn term.

**Young mums sewing group** stopped for the summer break and there will be discussions as to how that goes forward in the autumn. **Inside Out** continued over the break except during volunteers' holidays.

# Report of a Meeting of the Community Youth Partnership held at The Oakwood Centre on Wednesday 2 September 2015 at 5pm

#### **DECLARATIONS OF INTEREST**

No declarations of interest were made.

#### **MINUTES OF THE PREVIOUS MEETING**

The minutes of the meeting held on 27 May 2015 were agreed as a correct record.

#### **LODDON MEAD AREA – POTENTIAL PROJECT**

The Chairman reported on the covenants on the site which were: no permanent structure being allowed to be built there and the requirement for access to under the A road above to be maintained. He also reported on the site visit made by some of the project panel members along with officers from Wokingham Borough Council and the Town Council. It was noted that Cllr Richard Dolinski had also visited the site separately. There was general agreement that the space could provide a real opportunity for a variety of activities for young people. During the site visit it had been agreed that vehicle access to the area be followed up with Highways. No information had yet been provided and Deborah Mander agreed to follow up on this.

There was general agreement that the age range of young people to be targeted for the activities at the site would be the same as those for the partnership, ie 10-18 year olds - with the understanding that both older and younger could also be involved. General agreement was also given to the proposal from the Chairman that the process for defining the activities for the area should not be by competition but by consultation and discussion with young people and that this should be a wider area than just Woodley, given that young people travel to school and tend to use facilities outside their areas already.

It was agreed that the panel members along with the Chairman and Vice Chairman of the partnership would meet on Wednesday 16 September 2015 at 5pm at the Oakwood Centre to receive any information from Highways and to prepare information that could go out to schools and organisations working with young people to let them know about the consultation and ask them to take part. Paul Cassisdy offered to liaise with Waingels School, Richard Dolinski with

Bulmershe School and Trina Farrance provided information about the Schools Sports Coordinators locally who she thought would be willing to be involved.

Some ideas for activities at the site mentioned at the meeting included street art, parkour/free running, outdoor cinema, climbing wall, BMX track. The meeting agreed that it was likely that these kinds of activities would be attended by young people who could come by bike, on foot or be dropped off by parents and that these were probably going to be more realistic options for the site, given the road layout.

# **READING FC – WOODLEY PROJECTS AND EDUCATIONAL PROGRAMMES**

Paul Brown from Reading FC explained the work they were doing, funded by the Premier League Charity, to provide opportunities for local young people, both boys and girls. In Woodley a free 'Kicks' session runs on Mondays between 3 and 5pm at Goals for ages 11 - 19, (9 and 10 year olds can attend with parental permission). Paul is hoping to attract more Woodley youngsters to the sessions where the aim is to engage with young people, get them active and reduce anti social behaviour. They run four further sessions in Wokingham Borough, including cheerleading at St Crispins. The club has engaged with 836 different young people this year in the borough. The scheme is also a education pathway for young people and includes traineeships, apprenticeships and a Princes Trust Programme. The club can provide a wide range of educational sessions on various matters at the 'Kicks' sessions.

It was suggested that the club could contact Beechwood and Rivermead Primary Schools in Woodley where there may be a positive response. Deborah Mander agreed to include information about the session in the next Woodley Herald.

#### **FUNDING REQUEST**

It was agreed that this item would go forward to the agenda for the meeting on 21 October when it was hoped that more information about the funding request would be provided.

# YOUTH SHELTER – WOODFORD PARK

The Chairman reported that he and Deborah Mander had discussed a project to work with young people to refurbish the youth shelter in Woodford Park. Funding from an earmarked reserve for youth projects could be used for this and the Chairman also intended to seek some sponsorship from a local company.

#### **REGISTER OF INTERESTS**

Deborah Mander provided information about the requirement for the appointed voluntary sector members of the partnership to complete a register of interests form under the Council's Code of Conduct. This would involve the completed forms being available on the Town and Borough Council websites and the forms and guidance would be sent out to all the appointed members representing the voluntary sector for them to complete and return.

The Chairman welcomed everyone to the meeting and everyone present introduced themselves.

#### Appointed Representatives to WTCMI for this municipal year 2015 / 2016

The appointments of 2 Wokingham Borough Council WTCMI representatives, Cllr Keith Baker and Cllr Kate Haines, with Cllr Beth Rowland as substitute were noted.

The appointments of 2 Woodley Town Council WTCMI representatives, Cllr Dave Mills and Mrs Mary Holmes were noted.

#### Minutes of the TCMI meeting held on the Wednesday 8 April 2015

It was agreed that the minutes of the above meeting be approved.

# **Security in the Town Centre - Police Report**

There were no representatives from the Police as they'd all been diverted to be on duty at Henley Regatta. The Chairman said she'd been told that there was in fact little to report. However, all Woodley traders present disagreed and believed crime has been escalating in the Town Centre and more preventative measures are required. PB stated that a strong PCSO presence would make a major difference, although he understands they are stretched, but there is rarely a PCSO to be seen in the Town Centre and response times are slow. JD commented that lack of CCTV makes the Town Centre much more of a target and it was unfair that the traders have to bear the cost of losses incurred. JW also felt there were concerns for both people's safety and property. KB advised that CCTV was the responsibility of the police.

MM pointed out that the old cameras should have been left in place as a deterrent to which JD suggested that dummy cameras could be a cheap and effective measure. IH asked if perhaps a local community group / neighbourhood watch would be a possibility but it was agreed that this would prove difficult to organise.

Overall crime reports are not reflecting the number of incidents taking place and it was agreed that all crimes should be reported to the Police and a summary report of all these crimes be submitted by traders to the Town Centre Manager on a quarterly basis.

# Financial Report to end of year Budget Report - Final Audited Report 2014/15

Current bank balance of £88,098.12 as of end of May had now been officially finalised and audited. Net income for the year was £6,262 with the TCMI reserve standing at £72,340, including the £10,000 from the Mary Portas bid application. SS questioned the time limit on using the funds from the Mary Portas bid and it was confirmed that there was none.

KB questioned the £600 difference between 2014 and 2015 in respect of miscellaneous expenditure. JL had already queried this with the auditor and advised the meeting that the extra costs included our annual subscription to the ATCM (Association of Town & City Management),

some ramp equipment & the Linda Doyle court fees. MH suggested that the annual ATCM subscription should be listed separately in next year's accounts.

The audited accounts for 2014/2015 were approved by the voting members present and the chairman signed them off, asking that we write to Alan Harland to thank him for his work as our auditor.

#### **Town Centre Manager's Report**

The Town Centre Manager presented his report.

It was agreed that the defibrillator would be placed in an alternative location due to the lack of response from the Landlord of the Iceland block to locate it on its wall. It was agreed that JL should now seek permission from Woodley Town Council for it to be affixed to the base of the clock tower. In response to a question on training JL advised that use of the defibrillator is self-explanatory but free training is available from the Lily-May Trust. IH added that information can be found on YouTube as an alternative method for training. There was some concern that the defibrillator was at risk from vandals.

JL announced that a prospective new trader has decided against moving into the ex-Warrens Pet Shop unit, but another business is now very interested and is expected to exchange contracts in the near future. There had also been a planning application submitted to Wokingham Borough Council to turn part of the first floor above Iceland into a dance studio. The first floor flats above Iceland are being refurbished and should be finished by the end of July. It is unknown at present as to whether these will be to rent or buy.

JL reported that the Executive Sub Committee had previously approved a window sticker for the traders who contributed financially to the WTCMI in 2014/15 and the first one was presented to Mark Norris (H. F. Newberry). The remaining ones will be issued to contributors next week.

KB advised that the scheme *Beat the Street* had been successful and that Woodley had done better than Embrook in Wokingham. He also advised that the boxes were to be removed but the scheme may be repeated with WBC considering buying its own boxes. JD pointed out that traders had not been informed of the *Beat the Street* scheme. JL said he had been assured by the company involved that all those concerned would be made aware.

MM expressed concern about the proximity of one of these boxes, near Brightons, to an electrical supply box and its associated cables. MM has contacted WBC about his concerns but met with no response. JL agreed to liaise with our Saturday Market Manager over this matter and took MM's photographic evidence.

#### North End Town Centre Improvements

KB informed the meeting that significant developers' contributions from local developments for children's play facilities had been identified which can be allocated to the refurbishment of the town centre. The project at the town centre, which will require the services of a project manager, will be a joint project with WBC, WTC and WTCMI moving forward together for the good of the whole of the Town Centre. Initially, internal meetings will take place to discuss the possibilities and an eventual proposal will go before the WTCMI prior to going forward. JD asked if the proposal would be put to the general public. KB advised this would be a possibility through a public meeting.

IH asked about the current situation with the planned Town Centre public toilet. KB advised that the Town Council was still moving ahead with the single toilet, with costs amounting to £100,000 to build and estimated running costs of £10,000 per annum net of income with a charge of 20p a time. However, the loss of the 3 parking spaces at the Crockhamwell Road car park for this project has another financial implication and this matter is currently being negotiated. KB also pointed out that there was now an anti-toilet group of people on the social media web site StreetLife, who were asking why public funds were being spent on this when there was a Local Loo scheme. In the recent past, there had been petitions submitted by asking for a new public toilet and the Town Council organised a survey to pinpoint the best place for one to be built.

JY stated that in Wokingham Town Centre the Rose Street Public toilet was not used in great numbers and suggested it would be better to stick with the Local Loo scheme in Woodley and

improve signage. It was noted that this was something the Town Centre Manager had been requesting assistance with from WBC for 3 years.

KB suggested that if the signage for the Local Loos were dramatically improved, making everyone aware of these facilities, a new public toilet may not be required and the budget could be used to better the Town Centre in other ways. Posts with finger signs on them, the mushroom, the advertising pillars, waste bins and car parks, could all be used for signage and maps identifying not only local loos but also the shops and any other facilities within the Town Centre.

# **Any Other Business**

JD was concerned for the safety of the public crossing at the service area behind the HSBC Bank as this area can be confusing for both motorists and pedestrians. KB suggested that humps would be a possibility, being the easiest and cheapest to install. Similarly, JL was concerned for the public safety in the WBC Headley Road car park (near Lidl and the Library) where there have been several incidents.

JL reported that a planning application had been submitted to WBC by Brown Bag for some extra seating outside his business in Library Parade.

# (ADDINGTON GARDENS AND LODDON BRIDGE ROAD, WOODLEY) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 2015

On 9th December 2014, in consultation with the Executive Member for Highways and Planning, it was agreed to advertise and consult on a scheme to prohibit waiting on Addington Gardens, Woodley and restrict waiting on Loddon Bridge Road, Woodley.

The extents of these restrictions are shown on the attached plan and associated documents are also available online at <a href="https://www.wokingham.gov.uk/tro">www.wokingham.gov.uk/tro</a>

The highway along the lengths of Addington Gardens is yet to be adopted but it has been agreed to advertise a Traffic Regulation Order and have it in place when the road is handed over to the Council. The developer agreed to place parking restrictions in appropriate locations on the development before it was adopted and this has been completed. An informal consultation with residents was carried out in June 2014 regarding these parking restrictions and at that time some minimal changes were made. It is now appropriate to legalise these restrictions so that the police can carry out any necessary enforcement when the road has been handed over to the Council.

In additional timed parking restrictions will be placed opposite the entrance to Addington Gardens on Loddon Bridge Road which will run parallel to the School Keep Clear lines so that this area remains free of parked vehicles during the peak school times.

Any objections to the new proposals, together with the grounds on which they are made, should be sent in writing to the Traffic Management Team in Environment Services, P.O. Box 153, Shute End, Wokingham, Berkshire, RG40 1WL or by email to traffic.management@wokingham.gov.uk by no later than the 15<sup>th</sup> July 2015.




