Before opening the meeting the Chairman asked for a minute's silence in recognition of the tragic events and loss of life taking place in Ukraine, noting that all Councillors and those in attendance were united in opposition against the Russian Governments actions.

Apologies for absence were received from Councillors J Cheng, R. Skegg and B. Soane.

#### 93. **DECLARATIONS OF INTEREST**

Councillor P. Wicks – Prejudicial interest: Agenda item 8: Premises Licence Application in relation to Vibez Dance Studios, as Councillor Wicks visits the dance studios regularly.

Councillor Wicks took no part in the discussion or decision regarding the premises licence application. As Councillor Wicks is the Chairman of the Committee, and in the absence of the Vice-Chairman, Councillor Rahmouni proposed, seconded by Councillor Sartorel, and following a vote it was:

# 94. MINUTES OF THE PLANNING AND COMMUNITY COMMITTEE MEETING HELD ON 1 FEBRUARY 2022

Members noted that the minutes, as circulated as part of the agenda, had already been amended to correct two typography mistakes regarding the word 'licence', and to correct the reference to 'Headley Road' in minute 89 to read 'Headley Road East'.

#### **RESOLVED:**

♦ That the minutes of the Planning and Community Committee meeting held on 1 February 2022 be approved and be signed by the Chairman as a true and accurate record.

#### 95. WOKINGHAM BOROUGH COUNCIL ACTIVE TRAVEL ROUTE

The Chairman invited Andy Glencross, Wokingham Borough Council Assistant Director for Highways and Transport, to provide an update on the Active Travel Route consultation.

Andy confirmed that, following the public consultation, it was clear that those responding did not like the scheme as consulted and, as such, the design proposed would not be taken forward. Only high level results were known at this stage, and a full report regarding the consultation outcome would be published in due course.

Following discussion around the lack of consultation with the Town Council and affected residents prior to the formal consultation being issued Andy confirmed that, whilst prior consultations had publicised the general principle of the scheme, this did not go into detail. Andy confirmed that was WBC's fault, and apologised for this.

A suggestion was made that WBC would be better to spend the money they have on improving the cycle route where it was currently more dangerous, specifically the route along Church Lane and Culver Road. It was noted that the route along Woodlands Avenue was not perceived to be that dangerous. Andy confirmed that the scheme will be revised and comments taken into account.

Following a query regarding the decision making process at WBC, Andy confirmed that an Individual Executive Member Decision had been made in 2021 by Councillor Jorgensen asking WBC Officers to progress the scheme to design stage. Councillor Nagra highlighted that, in the minutes of the Planning & Community Committee meeting held on 1 February 2022, it had been stated that Borough Councillors had not been made aware of the proposed one way system. Andy confirmed that Councillor Jorgensen was aware of the scheme and that the specific design should've been communicated to both Borough Ward Councillors and the Town Council prior to the full consultation being issued. Councillor Jorgensen stated that the reason it was not communicated was because of a breakdown in communication between the Highways department and the Communications Team at WBC. She stated this should not have happened and will not happen again. Councillor Jorgensen also clarified that the Individual Executive Member Decision related to designing a scheme for consultation.

Andy advised the meeting that the Government's guidance now requires cycle route design to not only focus on segregating cyclists from cars, but also cyclists from pedestrians. It was acknowledged that this presents more challenges when trying to design cycle routes for existing highways.

Following a request to ensure both Woodley and Earley Town Councils are given sight of the revised scheme prior to any further consultation, Andy confirmed that discussions are taking place with a view to involving Town Councils in design workshops.

The Chairman confirmed that the Council agreed there was a need for improved cycle routes in Woodley, but that it was important that the Town Council are involved in the design of such routes to ensure they are suitable.

At this point the Chairman invited those who did not wish to remain for the rest of the meeting to leave. 6 members of the public remained.

It was also recommended that Councillor Bragg's details be sent to PC Lee Turnham, Community Speedwatch Coordinator for Thames Valley Police, in order that a Speedwatch group could be set up in the Council's name.

#### **WOKINGHAM LOCAL PLAN – DRAFT ANTI-POVERTY STRATEGY**

The Woodley Town Council's Planning & Community Committee have reviewed the draft Anti-Poverty Strategy (2022-26) and wish to submit the following comments on behalf of the Council.

This Council believes that the source of poverty should be addressed, rather than simply looking to implement measures to mitigate them. Many of the problems are viewed as temporary and are being passed to charities to deal with, and we feel the strategy fails to act in areas under the Borough Council's control or within their sphere of influence.

The strategy refers to free school meals but does not appear to address other schooling expenses families face, such as expensive school uniforms and IT equipment. There is also a focus on getting people into work to solve the problem, but the strategy seems to ignore in-work poverty.

With regards to the groupings provided within the strategy, we believe the third grouping, 'Asset Rich, Cash Poor' needs to acknowledge that, in a lot of cases, assets cannot be liquidated through no fault of the individual. At present it is worded in a way which seems to suggest the group covers those with large properties and low cash through their own choice, and we believe this is probably unfair. We would encourage terminology which reflects the true nature of this type of poverty; ie 'people unable to liquidate their property assets due to health or similar issues'.

We also believe it might be helpful for the strategy to explore short term poverty; people hit with short term challenges, such as unexpected large bills or housing issues, for example, having a tenancy end and needing to raise a deposit for a new rental.

With regards to the objectives, we believe the content of the strategy is probably far more ambitious than the objectives show. We would like to see the first objective re-worded to be more like 'Help people to manage and escape from poverty' rather than just supporting people in poverty.

Our only other concern is the reliance on the voluntary sector within the strategy.

We hope these comments are helpful in the creation of the final strategy, which we look forward to seeing.

#### **REPORT**

#### **EARLEY FOOTBRIDGE**

#### **ON-LINE VIA TEAMS ON 7 MARCH 2022**

Meeting instigated by Andy Glencross -WBC

#### **SCOPE**

The Meeting was called to discuss the latest reviews of the proposal for the replacement Footbridge from Woodley (Nightingale Road) to Earley Station.

This is to be read in conjunction with the previous reports from earlier meetings.

#### **NOTES TAKEN**

The presentation was made by George Nidhish (Project Manager) at times supported by Jimmy Barratt-Thorne (Designer).

Three Options have been reviewed in more detail.

1. Option 1 To provide lifts at each end plus a staircase in lieu of the current ramps.

This would be cheaper at construction time and remove a lot of the distance to be travelled

Glass fronted lifts would not be suitable as they would be more subject to vandalism.

We would need steel, vandal proof equipment which would cost £105K plus the shafts and the staircases. The lift shafts would rise 4 metres above the bridge platform and the lifts would have a life of up to 20 years. They would be sized for 17 persons, 2 cycles and wheelchairs.

They would need 6-monthly inspections and CCTV Monitoring which may have to be 24/7.

Vandalism and other forms of misuse would suggest they may require regular repair, maintenance, and cleaning. The monitoring company would need to attend within a short period of time in the event of a breakdown but in an emergency the Fire and Rescue Service may attend and cause more damage in releasing persons trapped.

Financially the cost over 120 years may not be much different from the full ramp suggestion - which is the preferred option of the Designers. Discussion included that from a lift manager who said that his previous experience would preclude lifts due to reliability and the fact they were isolated from management. The type of lift also may not be welcomed at night using a steel box type car as there would be no visibility from the lift and may affect some persons willingness to use them.

- 2. Option 2 was to ask SGB to move the gas main which is causing the issues about position of the replacement bridge. SBG have advised a budget of £5 million to move the pipe. The gas pipeline is High Pressure and SGB will not consider any work within a 40-foot diameter from the current position. The law apparently allows them to refuse. The movement of the high-pressure gas main would save up to £1m but with the estimated cost to move it of £5m the net increase in spend is £4m. It could take 2 years to move.
- 3. Option 3 was to repair the current structure. It appears that SGB cannot object to this. The estimated cost to repair would be between £1 and £2 million but could extend the bridge life by between 10-20 years, however, there is no guarantee of this, and the designers are unable to say how long the repaired bridge may last until condemned.

The bridge is due a major condition review in 2022 (carried out every 6 years) This review will require a very close inspection and it is unknown what this inspection may find. The current structure is crumbling, and the risk exists that it may be closed if it is found to be potentially dangerous to vehicles and trains beneath as well as to the users.

My comment was that the length any disabled or unfit person may have to travel along the ramps may dissuade them from using the bridge, but it is unlikely they use the bridge now anyway.

Irrespective of which option moves forward the bridge will be closed for a lengthy period during the repair or replacement, assuming it is not condemned in the meantime, in which case it may be closed for a lot longer.

More surveys may need to be carried out to establish usage.

Comment from Earley Town Council representatives suggested the ground is owned by the Town Council and they may be reluctant to allow it to be used. Pressure to use the underpass at Clivedale Road with some changes to the barriers on the slopes to assist cyclists (Not DDA Compliant). Not a good option in my opinion.




# **Currently Recommended Option (middle ramp optional)**






Current preferred span + lifts and stairs at the end (lift and stairs in the middle optional)





# Repairing the existing bridge

### **Scope**

- Repairs to include (but not limited to):
  - Main Spans: possible strengthening to the stringers, prepare and paint the stringers, patch repairs to the concrete deck
  - Approach Ramps: patch repair to the approach ramps, repair concrete columns, install cathodic protection to approach ramps and columns, installing long term monitoring of the half joints
  - General: constructing a new concrete stringcourse throughout, new parapet throughout, replace/refurbish bearings, replace expansion joints, waterproof and resurface the deck and approach ramps
- replacement of the approach ramps may be more cost effective
- Indicative cost range: £1m £2m

### **Pros**

- SGN are much less likely to be able to object to these works
- The capital cost of the works will be less than that of other options.
- Less impact on ETC & RBC land (Woodley side)
- Minimal environmental impact



# Repairing the existing bridge

### **Cons**

- A definitive service life cannot be designed for Potentially 10-20 years (with plenty of caveats!)
- There is a risk that the condition of the repairs deteriorate or that the monitoring gives cause for concern; which could result in the footbridge being closed or propped at short notice
- No improvement on the current accessibility for disabled users or cyclists
- There is a lack of recent Principal Inspection (touching distance inspection) records for the railway span. A Principal Inspection is planned for the next financial year, this might reveal defects which have not been considered. Current assessment based on ongoing quarterly monitoring & last PI in 2016.

#### **Dear Consultation Respondents**

On <u>26 January 2022</u> the Licensing and Appeals Committee discussed potential changes to the tariffs in the Wokingham area based on a business case put forward by representatives of the trade. The Committee agreed to recommend that a statutory consultation be undertaken on a proposal to vary the tariffs as summarised below:

- Bring forward the time the tariffs change from one rate to another from 11pm to 10:30pm;
- Change the Flag Rate from 863 yards and 190 secs to 440 yards/150 secs;
- Amend the Rate from 167 yards/38 secs to 120 yards/30 secs;
- Increase the fouling charges from £10 (interior) and £50 (exterior) to £15 and £75 respectively;
- Increase the charge for an extra passenger where the vehicle is transporting more than 4 passengers from 50p to £2.00 per passenger.

Thank you for the response that you submitted during the consultation period which ran from the 03 February 2022 to the 17 February 2022. I have previously sent the outcome of that consultation to you but in case you would like to revisit it you can find it here

As objections to proposed changes were received and not withdrawn the matter had to be considered again by the Committee to decide whether or not to modify the table of fares before it came into effect. The objections were therefore discussed by Members of the Licensing and Appeals Committee at a meeting on the <u>02 March 2022</u>.

The Committee agreed, after considering all the information presented to them, that they would support the case put forward by the trade. The only changes related to the

implementation date which they pushed back to the 04 April 2022 to accommodate a request from the meter agencies to do so and a change to the initial flag waiting time which they reduced from 150 seconds to 110 seconds so that the tariffs could be accommodated on some of the older meters.

The Licensing and Appeals Committee reflected on the fact that this was the maximum tariff that could be charged and drivers and operators would not have to implement it if they did not want to. Customers could negotiate lower tariffs prior to the journey commencing. They also noted that this was the first uplift to the fares since 2010 and that a number of other authorities were also currently reviewing their tariffs or were likely to do so during the forthcoming year.

# Outcome of the Statutory Hackney Carriage Tariff Consultation

### Background

Wokingham Borough Council is committed to balancing the legitimate aims of the taxi trade to maintain profitability in the face of increasing costs, while protecting the public from excessive fares. The issue of setting fares for hackney carriage drivers is an important one for two reasons. The fare set by licensing authority largely determines the ability of drivers to earn a decent living but also aims to ensure that passengers receive a fair deal when taking a journey in a licensed hackney carriage.

The current hackney carriage fare scale was agreed in 2010 albeit that a minor variation was agreed in 2014. In December 2021 the Council was approached by the trade to consider a variation of the fees. The business case put forward by the trade cited the increasing costs that they were incurring.

The proposal to amend the fees was discussed at the <u>26 January 2022</u> Licensing and Appeals Committee where Members agreed to undertake a statutory consultation on the proposals put forward by the trade. The consultation ran from the 03 February to the 17 February 2022.

The proposed changes put forward by the trade can be summarised as:

- Bring forward the time the tariffs change from one rate to another from 11pm to 10:30pm;
- Change the Flag Rate from 863 yards and 190 secs to 440 yards/150 secs;
- Amend the Rate from 167 yards/38 secs to 120 yards/30 secs;
- Increase the fouling charges from £10 (interior) and £50 (exterior) to £15 and £75 respectively;
- Increase the charge for an extra passenger where the vehicle is transporting more than 4 passengers from 50p to £2.00 per passenger.

#### Who and How we Consulted

- A notice was placed in the Wokingham Today newspaper on the 03 February 2022.
- The consultation was also published on the Public Protection Partnership's website.
- A copy of the notice was also placed on the Shute End noticeboards on the 02 February 2022
- A copy of the notice was emailed individually to all licensed Hackney Carriage Proprietors for their comments.
- Social media posts were put out to signpost residents to the consultation.

### What you Told Us

We received the following objections and comments on the proposed modifications:

I'm writing to express my objection at the proposed increase to the fares.

	It is a challenging time for everyone late and appreciate the same applied to those that work in the industry, however, the increase in fares will make the use of taxis prohibitive for many who need to rely on such mode of transport for health matters (hospital appointments) and on occasion to work (for example social care teams where they are unable to drive to work).  Furthermore it will introduce risk to individuals who may be needing transport late and night and decide to walk home as they are unable to afford the revised fares.
Resident	I do think that fares should be set at a higher rate, if the licensed cabs wish it.  I usually take Ubers instead though, which are much cheaper, and I think this will drive more business that
	way. I'm happy we have options.
Resident	Re the current consultation on taxi fare increases, a rise in the cost appears justified in all the circumstances. The level of increase must, however, be a reasonable one. And with the rise, there needs to be an improvement (monitored regularly by Wokingham Council) in the quality and cleanliness of the taxis for hire at Wokingham station, and their meters must be clearly visible to customers sitting in the rear of the vehicle.
Meter Company	Your proposal doesn't follow taximeter rules OIML and R21 which have been in force for many years. The rule takes the flag distance divided by the increment distance Multiplied by the increment time. So many older meters make this calculation and apply it automatically and have no provision to change this as it is a standard used all over the world.
	Many new ones can do it automatically or be adjusted.
	On your proposal 440 divided by 120 equals 3.666 X 30 Equals 110 seconds not 150.
	So meters that can't change this because it's automatic would drop 40 seconds early which is overcharging and they would have to be removed
	Your options are:  • Remove the meters

Town Council	Whilst the Committee acknowledge that rates have not changed since 2010, the Committee object to the level of increase being proposed.
	When comparing against other neighbouring authorities, the Committee believe the cost to be too high. Using a 7 mile journey for comparison, the proposed charges will increase the cost of a journey from around £16.70 to £22.80. A similar journey via Uber is estimated at £11, whilst the cost of the same journey in Bracknell Forest is £15 and in RBWM is £17.50.
	The Committee believe rates should be comparable to those of neighbouring authorities.

### Next Steps

The Local Government (Miscellaneous Provisions) Act 1976 section 65 gives a Local Authority the power to determine the table of fares for the hire of hackney carriages. This legislation also prescribes the statutory consultation process that must be followed and the procedures for ensuring that objections are properly considered in relation to a Local Authority's adoption of or variation to a table of fares before the table comes into effect.

As objections to the varied table of fares were received (see table above) and not withdrawn the matter had to be considered further to decide whether or not to modify the table of fares before it came into effect. The objections were therefore discussed by Members of the Licensing and Appeals Committee at a meeting on the <a href="#o22"><u>02 March</u></a> 2022.

The Members were informed that the table of fares had to come into operation by the 17 April 2022 i.e. no later than two months after the last date for making objections (17 February 2022) with or without modification.

#### Conclusion

Members of the Licensing and Appeals Committee, after considering the business case put forward by the taxi trade, the comments received during the consultation and the response to those comments by the taxi trade have agreed to:

- Bring forward the time the tariffs change from one rate to another from 11pm to 10:30pm;
- Change the Flag Rate from 863 yards and 190 secs to 440 yards/110 secs;

- Amend the Rate from 167 yards/38 secs to 120 yards/ 30 secs;
- Increase the fouling charges from £10 (interior) and £50 (exterior) to £15 and £75 respectively;
- Increase the charge for an extra passenger where the vehicle is transporting more than 4 passengers from 50p to £2.00 per passenger.
- An implementation date of the 04 April 2022.
