Common Seal Penalty Note Wokingham Borough Council under and by virtue of the powers and authority vested in them by section 66 of the Land Drainage Act 1991, do hereby make the following Byelaws which are considered necessary for [one or more of] the following purposes:-

a) securing the efficient working of a drainage system in the Council's area,

b) regulating the effects on the environment in the Council's area of a drainage system,

c) securing the effectiveness of flood risk management work within the meaning of section 14A of that Act, or

d) securing the effectiveness of works done in reliance on section 38 or 39 of the Flood And Water Management Act 2010 (incidental flooding or coastal erosion),

together, "the Purposes";-

#### 1. Commencement of Byelaws

These Byelaws shall come into operation at the expiration of one month beginning with the day on which they are confirmed by the Secretary of State.

#### 2. Application of Byelaws

(a) These Byelaws shall have effect within the Area;

(b) the watercourses referred to in these Byelaws are watercourses which are for the time being vested in or under the control of the Council.

# 3. Control of Introduction of Water and Increase in Flow or Volume of Water

No person shall as a result of development (within the meaning of section 55 of the Town and Country Planning Act 1990 as amended ("the 1990 Act")) (whether or not such development is authorised by the 1990 Act or any regulation or order whatsoever or none of them) for any purpose by means of any channel, siphon, pipeline or sluice or by any other means whatsoever introduce any water into any watercourse in the Area so as to directly or indirectly increase the flow or volume of water in any watercourse in the Area (without the previous consent of the Council).

#### 4. Control of Sluices etc

Any person having control of any sluice, water control structure or appliance for introducing water into any watercourse in the Area or for controlling or regulating or affecting the flow of water in, into or out of any watercourse shall use and maintain such sluice, water control structure or appliance in accordance with such reasonable directions as may from time to time be given by the Council with a view to securing or furthering one or more of the Purposes.

# 5. Diversion or Stopping up of Watercourses

No person shall, without the previous consent of the Council, take any action, or knowingly permit or aid or abet any person to take any action to stop up any watercourse or divert or impede or alter the level of or direction of the flow of water in, into or out of any watercourse.

# 6. Detrimental Substances not to be Put into Watercourses

No person shall, so as directly or indirectly to obstruct, impede or interfere with the flow of water in, into or out of any watercourse or so as to damage the bank -

(a) discharge or put or cause or permit to be discharged or put or negligently or wilfully cause or permit to fall into any watercourse any object or matter of any kind whatsoever whether solid or liquid;

(b) allow any such object or matter as is referred to in sub-paragraph (a) of this Byelaw to remain in proximity to any watercourse in such manner as to render the same liable to drift or fall or be carried into any watercourse. Provided that nothing in this Byelaw shall be deemed to render unlawful the growing or harvesting of crops in accordance with normal agricultural practice.

#### 7. Notice to Cut Vegetation

Any person having control of any watercourse shall, upon the receipt of a notice served on him by the Council requiring him so to do, cut down and keep cut down all vegetation, including trees, growing in or on the bank of a watercourse, within such reasonable time as may be specified in the notice, and shall remove such vegetation, including trees, from the watercourse immediately after the cutting thereof.

Provided that, where a hedge is growing on the bank of a watercourse, nothing in this Byelaw shall require more than the pruning of the hedge so as to prevent it from growing over or into the watercourse, and the removal of the resultant cuttings.

# 8. No Obstructions within 8 Metres of the Edge of the Watercourse

No person without the previous consent of the Council shall erect any building or structure, whether temporary or permanent, or plant any tree, shrub, willow or other similar growth within 8 metres of the landward toe of the bank where there is an embankment or wall or within 8 metres of the batter where there is no embankment or wall, or where the watercourse is enclosed within 8 metres of the enclosing structure.

#### 9. Repairs to Buildings

The owner of any building or structure in or over a watercourse or on the banks thereof shall, upon receipt of a notice from the Council that because of its state of disrepair -

(a) the building or structure is causing or is in imminent danger of causing an obstruction to the flow of the watercourse;

(b) the building or structure is causing or is in imminent danger of causing damage to the bank of the watercourse, carry out such reasonable and practicable works as are specified in the notice for the purpose of remedying or preventing the obstruction or damage as the case may be within such reasonable time as is specified in the notice.

#### 10. Control of Vermin

The occupier of any bank of a watercourse or any part thereof shall, upon being required by the Council by notice, within such reasonable time as may therein be specified, take such steps as are specified in the notice, being such steps as the Council consider necessary and practicable for preventing the bank from becoming infested by rabbits, rats, coypu, foxes and moles or any other wild mammal not being an animal listed in Schedule 5 or Schedule 6 to the Wildlife and Countryside Act 1981, but excluding the water vole from such control.

#### 11. Damage by Animals to Banks

All persons using or causing or permitting to be used any bank of any watercourse for the purpose of grazing or keeping any animal thereon shall take such steps including fencing as are necessary and reasonably practicable and shall comply with such reasonable directions as may from time to time be given by the Council to prevent the bank or the channel of the watercourse from being damaged by such use. Provided that nothing in this Byelaw shall be deemed to affect or prevent the use of, for the purpose of enabling animals to drink at it, any place made or to be made or constructed as approved by the Council.

#### 12. Vehicles not to be Driven on Banks

No person shall use or drive or permit or cause to be used or driven any cart, vehicle or implement of any kind whatsoever on, over or along any bank of a watercourse in such manner as to cause damage to such bank.

#### 13. Banks not to be Used for Storage

No person shall use or cause or permit to be used any bank of any watercourse for the purpose of depositing or stacking or storing or keeping any rubbish or goods or any material or things thereon in such a manner as by reason of the weight, volume or nature of such rubbish, goods, material or things causes or is likely to cause damage to or endanger the stability of the bank or channel of the watercourse or interfere with the operations or access of the Council or the right of the Council to deposit spoil on the bank of the watercourse.

# 14. Not to Dredge or Raise Gravel, Sand etc

No person shall without the previous consent of the Council dredge or raise or take or cause or permit to be dredged or raised or taken any gravel, sand, ballast, clay or other material from the bed or bank of any watercourse.

# 15. Fences, Excavations, Pipes etc

No person shall without the previous consent of the Council -

(a) place or affix or cause or permit to be placed or affixed any gas or water main or any pipe or appliance whatsoever or any electrical main or cable or wire in, under or over any watercourse or in, over or through any bank of any watercourse;

(b) cut, pare, damage or remove or cause or permit to be cut, pared, damaged or removed any turf forming part of any bank of any watercourse, or dig for or remove or cause or permit to be dug for or removed any stone, gravel, clay, earth, timber or other material whatsoever forming part of any bank of any watercourse or do or cause or permit to be done anything in, to or upon such bank or any land adjoining such bank of such a nature as to cause damage to or endanger the stability of the bank;

(c) make or cut or cause or permit to be made or cut any excavation or any tunnel or any drain, culvert or other passage for water in, into or out of any watercourse or in or through any bank of any watercourse;

(d) erect or construct or cause or permit to be erected or constructed any fence, post, pylon, wall, wharf, jetty, pier, quay, bridge, loading stage, piling, groyne, revetment or any other building or structure whatsoever in, over or across any watercourse or in or on any bank thereof;

(e) place or fix or cause or permit to be placed or fixed any engine or mechanical contrivance whatsoever in, under or over any watercourse or in, over or on any bank of any watercourse in such a manner or for such length of time as to cause damage to the

watercourse or banks thereof or obstruct the flow of water in, into or out of such watercourse.

Provided that this Byelaw shall not apply to any temporary work executed in an emergency but a person executing any work so excepted shall, as soon as practicable, inform the Council in writing of the execution and of the circumstances in which it was executed and comply with any reasonable directions the Council may give with regard thereto.

#### 16. Interference with Sluices

No person shall without lawful authority interfere with any sluice, or other water control structure or appliance for controlling or regulating the flow of water in, into or out of a watercourse.

#### 17. Damage to Property of the Council

No person shall interfere with or damage any bank, bridge, building, structure, appliance or other property of or under the control of the Council.

#### **18. Defacement of Notice Boards**

No person shall deface or remove any notice Board, notice or placard put up by the Council.

#### 19. Obstruction of the Council and Officers

No person shall obstruct or interfere with any member, officer, agent or servant of the Council exercising any of his functions under the Act or these Byelaws.

#### 20. Savings for Other Bodies

Nothing in these Byelaws shall -

(a) conflict with or interfere with the operation of any Byelaw made by the Environment Agency or an internal drainage board or of any navigation, harbour or conservancy authority but no person shall be liable to more than one penalty or in the case of a continuing offence more than one daily penalty in respect of the same offence;

(b) restrict, prevent, interfere with or prejudice the exercise of any statutory rights or powers which are now or hereafter may be vested in or exercised by -

(i) any public utility undertaking carried on by a local authority under any Act or under any Order having the force of an Act;

(ii) the undertakings of the Environment Agency and of any water undertaker or sewerage undertaker;

(iii) any public gas transporter within the meaning of part I of the Gas Act 1986;

(iv) any navigation, harbour or conservancy authority;

(v) any person who acts as the operator of a relevant railway asset, with respect to the construction, use or maintenance and repair of any such asset, or the free, uninterrupted and safe use of any such asset and the traffic (including passengers) thereof;

(vi) any local authority;

(vii) any highway authority for the purposes of the Highways Act 1980 (as amended by any subsequent enactment) in relation to any highway whether or not maintainable at public expense;

(viii) any undertaking engaged in the operation of a telecommunications system;

(ix) a relevant airport operator within the meaning of Part V of the Airports Act 1986;

(x) the Civil Aviation Authority and any subsidiary thereof;

(xi) the Canal and River Trust;

(xii) the Coal Authority;

(c) restrict, prevent, interfere with or prejudice any right of a highway authority to introduce into any watercourse surface water from a highway, for which it is the highway authority;

(d) restrict, prevent, interfere with or prejudice any right of a licence holder within the meaning of Part I of the Electricity Act 1989 to do anything authorised by that licence or anything reasonably necessary for that purpose;

(e) affect any liability arising otherwise than under or by reason of these Byelaws.

#### 21. Saving for Crown Lands

Nothing in these Byelaws shall operate to prevent the removal of any substance on, in or under (or the erection of any structure, building or machinery or any cable, wire or pipe on, over or under) lands belonging to Her Majesty in right of the Crown by any person thereunto authorised by the Crown Estate Commissioners.

#### 22. Arbitration

443

(a) Where by or under any of these Byelaws any person is required by a notice in writing given by the Council to do any work to the satisfaction of the Council or to comply with any directions of the Council, he may within 21 days after the service of such notice on him give to the Council a counter-notice in writing objecting to either the reasonableness of or the necessity for such requirement or directions, and in default of agreement between such person and the Council the dispute shall, when the person upon whom such notice was served is a drainage or local authority be referred to the Secretary of State whose decision shall be final, and in any other case shall be referred to the arbitration of a single arbitrator to be appointed in default of agreement by the President of the Institution of Civil Engineers on the application of either party. Where such a counter-notice has been given to the Council the operation of the notice shall be suspended until either agreement has been reached or the dispute has been determined by arbitration in accordance with the provisions of this Byelaw;

(b) where by or under these Byelaws any person is required by a notice in writing given by the Council to do any work to the satisfaction of the Council or to comply with any directions of the Council and any dispute subsequently arises as to whether such work has been executed or such directions have been complied with, such dispute if it arises between a drainage authority or local authority and the Council shall be referred to the Secretary of State whose decision shall be final, and in any other case shall be referred to the arbitration of a single arbitrator to be appointed in default of agreement by the President of the Institution of Civil Engineers on the application of either party; (c) where by or under Byelaws 3, 6, 10, 16 or 17 any person is required to refrain from doing any act without the consent of the Council such consent shall not be unreasonably withheld and may be either unconditional or subject to such reasonable conditions as the Council may consider appropriate and where any dispute arises as to whether in such a case the consent of the Council is being unreasonably withheld, or as to whether any conditions subject to which consent is granted are unreasonable, such dispute shall if it arises between a drainage authority or local authority and the Council be referred to the Secretary of State whose decision shall be final, and in any other case such dispute shall be referred to the arbitration of a single arbitrator to be appointed in default of agreement by the President of the Institution of Civil Engineers on the application of either party.

#### 23. Notices

Notices and any other documents required or authorised to be served or given under or by virtue of these byelaws shall be served or given in the manner prescribed by section 71 of the Act.

#### 24. Limitation

(a) Nothing in these Byelaws shall authorise the Council to require any person to do any act, the doing of which is not necessary for securing or furthering one or more of the Purposes, or to refrain from doing any act, the doing of which does not affect the environment, or adversely affect either

(i) the efficient working of the drainage system of the area (ii)the effectiveness of flood risk management work within the meaning of section 14A of the Land Drainage Act 1991, or

(iii) the effectiveness of works done in reliance on section 38 or 39 of the Flood and Water Management Act 2010.

(b) If any conflict arises between these Byelaws and

(i) sections 61A to E of the Land Drainage Act 1991 (which relates to the Council's duties with respect to the environment), or

(ii) the Conservation of Habitats and Species Regulations 2010

The said Act and the said Regulations shall prevail.

#### 25. Interpretation

In these Byelaws, unless the context otherwise requires, the following expressions shall have the meaning hereby respectively assigned to them, that is to say:-

"the Act" means the Land Drainage Act 1991;

"Animal" includes any horse, cattle, sheep, deer, goat, swine, goose or poultry;

"Area" means the area under the jurisdiction of the Council;

"Bank" includes any bank, cross bank, wall or embankment adjoining or confining or constructed for the purpose of or in connection with any watercourse and includes all land between the bank and the low water mark or level of the water in the watercourse as the case may be and where there is no such bank, cross bank, wall or embankment includes the top edge of the batter enclosing the watercourse;

"Consent of the Council" means the consent of the Council in writing signed by a proper officer of the Council;

"Council" means the Council;

"Occupier" means in the case of land not occupied by any tenant or other person the person entitled to the occupation thereof;

"Ordinary watercourse" is any river, stream, ditch, drain, cut, dyke, sluice, sewer (other than a public sewer) and passage through which water flows and which does not form part of a main river network.

"Owner" includes the person defined as such in the Public Health Act 1936;

"Relevant railway asset" means

(a) a network, operated by an "approved operator" within the meaning of section 25 of the Planning Act 2008,

(b) a station which is operated in connection with the provision of railway services on such a network, or

(c) a light maintenance depot.

Expressions used in this definition and in the Railways Act 1993 have the same meaning in this definition as they have in that Act,( "railway" not having its wider meaning) and a network such as is described in (a) above shall not cease to be such a network where it is modified by virtue of having any network added to it or removed from it.

"The Secretary of State" means the Secretary of State for the Department for Environment, Food and Rural Affairs;

"Vegetation" means trees, willows, shrubs, weeds, grasses, reeds, rushes, or other vegetable growths;

"Vessel" includes any ship, hovercraft (as defined by the Hovercraft Act 1968), lighter, keel, barge, tug, launch, houseboat, pleasure or other boat, aircraft, randan, wherry, skiff, dinghy, shallop, punt, yacht, canoe, raft, float of timber or any other craft whatsoever, and howsoever worked, navigated or propelled;

"Water control structure" means a structure or appliance for introducing water into any watercourse and for controlling or regulating or affecting flow, and includes any sluice, slacker, floodgate, lock, weir, dam, pump, or pumping machinery;

and other expressions shall have the same meanings as in the Act.



#### PENALTY NOTE

By section 66(6) of the Act every person who acts in contravention of or fails to comply with any of the foregoing Byelaws is liable on summary conviction in respect of each offence to a fine not exceeding the amount prescribed from time to time for level 5 on the standard scale referred to in section 37 of the Criminal Justice Act 1982 and a further fine not exceeding Forty pounds for every day on which the contravention or failure is continued after conviction. By section 66(7) of the Act if any person acts in contravention of or fails to comply with any of these Byelaws the Council may without prejudice to any proceedings under section 66(6) of the Act take such action as may be necessary to remedy the effect of the contravention or failure and may recover the expenses reasonably incurred by it in doing so from the person in default.

## 1. Introduction

Our key responsibility is to make sure we provide an effective fire and rescue service for communities across Royal Berkshire. Our service is provided by Royal Berkshire Fire and Rescue Service, and your Chief Fire Officer Andy Fry and his team are overseen by the Fire Authority, who are ultimately accountable to you as residents and business owners.

**Our Mission:** RBFRS is committed to ensuring the communities of Royal Berkshire are able to lead safe and fulfilling lives.

In 2016, following a public consultation, the Fire Authority published its <u>Corporate</u> <u>Plan/Integrated Risk Management Plan (IRMP) 2015-2019</u>, setting out Royal Berkshire Fire Authority's strategic commitments to the communities of Royal Berkshire, and a new, exciting vision of how the service will look in 2019.

This consultation is the next stage in an ongoing programme of consultations, which will help us to understand your views as we shape the way we deliver our service to you. A key part of that work is to look at how we define and measure our response standards, that is the measurement of how long it takes our fire engines arrive at an emergency.





## 2. Current Position

Royal Berkshire Fire Authority considered the findings from the <u>IRMP 2015-19</u> <u>consultation</u> at a meeting on <u>25 April 2016</u>. They reached a decision to progress the four priority projects outlined in the previous consultation. The first key element of this work is to ensure our response standards are fit for purpose and are clear and easy to understand as we move towards developing these projects. You can read more about the IRMP 2015-2019 consultation, as well as our <u>Consultation Strategy</u> at <u>www.rbfrs.co.uk</u>

## 2.1 What do we currently do?

Currently, our published standards for attending incidents are as follows:



- 'We have an optimum response, where we are committed to attending an incident within 8 minutes for the first fire engine and 10 minutes for the second fire engine for dwelling fires'
- 'We have a standard response, where we are committed to attending in 10 minutes for the first fire engine and 12 minutes for the second fire engine for dwelling fires'
- 'Higher risk locations, where it is predicted that fire engines will not reach dwelling fires within the standard response, we will prioritise for Prevention initiatives'
- 'We are committed to making an initial attendance to road traffic collisions (RTCs) with the necessary resources to commence extrication of casualties, within 11 minutes'

These are reported and measured in the following ways:

- a) We currently use attendance standards this means we measure how long it takes a fire engine to get to an emergency incident, from the time the crew is mobilised by a control operator to the time the engine arrives on scene.
- **b)** We currently only measure attendances for dwelling fires and RTCs. All other incident types are not measured or reported on.

- c) We currently do not have a published target to achieve, instead we report our performance in terms of incidents previously attended.
- **d)** We currently have standards for both the first fire engine to arrive and in other circumstances for the second fire engine to arrive at incidents.

Our approach to emergency response is to ensure we have the right numbers of firefighters, fire engines and specialist appliances, at the right place, at the right time, delivering the right standard of response.

This will not change and it is our priority to always respond to a 999 call as quickly as we possibly can.



## 3. Why are we consulting on this?

Prior to the implementation of the Fire and Rescue Services Act 2004, RBFRS had a set of national standards for responding to fires. Professor Sir George Bain produced a wide-ranging <u>report</u> into how fire and rescue services were operated and managed, and about the working conditions of firefighters in the UK. On publication, the report set out recommendations for how fire and rescue services should change in the future to meet the demands of the twenty-first century.

In May 2013, Sir Ken Knight, in his report *'Facing the future'* stated:

*"It is for each fire and rescue authority to determine their own rules for response times."* 

In 2014, a <u>peer review</u> of RBFRS could not find rationale for our current response standards, this identified that they were overly complex, difficult to understand and should be realigned with the Fire Authority's new strategic commitments. This was in part because they do not currently align with the Department for Communities and Local Government (DCLG) definition of a <u>response time</u>:

"A response time measures the minutes and part minutes taken from time of call to time of arrival at scene of the first vehicle."

### 4. Looking Forward

RBFRS recognises it is important to review the way in which we report our current response standards and consult with the people of Royal Berkshire on any proposed changes to ensure the following:

**Clarity** – it is important that information presented about the measurement and reporting of response standards is clear and easy to understand for members of the public.

**Transparency** – it is important that RBFRS presents transparent information in relation to our response standards and performance against these standards.

**Manage and track our performance** – RBFRS needs to monitor, manage and track our performance against defined standards so that we can clearly report on these to the Fire Authority, members of the public and other key stakeholders.

**Reflect change in the nature of incidents** – RBFRS is committed to responding to the changing needs of our community and reflecting this in the way in which we respond to any new and emerging threats.

We are not, at this point in time, consulting on any changes to the location of fire stations, the number of fire stations or how these are crewed.

This consultation relates solely to how we define and report information on our performance when we respond to emergencies.

Later this year, we will be consulting on proposals and options for station locations, the number of fire engines we have and how these are crewed. This future consultation will shape our community risk management arrangements for at least the next four years.

## 5. How to get involved

The response standards consultation will run from Monday 16 May – Monday 25 July 2016.

It is important for RBFRS to consult on proposed changes to our response standards with all the people of Royal Berkshire. It is vital to us that we seek the views on any

proposed changes to our service delivery to ensure that the communities of Royal Berkshire have their say and play a part in shaping the future of RBFRS.

Over the following pages, we will present four distinct proposals for changing the way in which we currently define and report our response standards.

- Specifically, we are asking you to express your preferred choice for each of the four proposals
- For each proposal, we want you to tell us if you would like to keep it the same as it currently is, or to change it in line with the details given
- We would also appreciate your view and ideas on whether there is anything else we should consider in relation to this consultation



## Proposal 1: How should we measure the time taken to respond to an incident?

#### What we currently do:


- Our standard measures an *attendance* time
- An *attendance time* is measured from the time a Control operator alerts the crews at a fire station to the arrival of a fire engine at the incident



### <u>Or</u>

#### **Proposal for change:**

- An alternative is that the standard measures *response times*
- A *response time* is measured from the time the **call is received by** Control to the time a fire engine arrives at the incident



- Measuring *response times* would be a clearer measure that starts the clock running from the moment a caller dials 999.
- This aligns with the DCLG definition of a **response** time.

### Proposal 2: What types of incidents should we report on?

#### What we currently do:

• Our current attendance standard measures only those attendances to 'dwelling fires and road traffic collision (RTC) incidents'



#### **Proposal for change:**

• The standard should include 'all emergency incidents'




- Measuring 'all emergency incidents' would include all types of incidents, including flooding, rescues from height and chemical spills, as well as dwelling fires and road traffic collisions
- Measuring 'all emergency incidents' would reflect the changing nature of incidents occurring in Royal Berkshire and include new and emerging threats
- Measuring 'all emergency incidents' would give a more accurate reflection of what RBFRS does

# Proposal 3: How many fire engines should be measured in the response standard?

#### What we do currently:

• Our current measures: for dwelling fires, there is a two fire engine response standard and for RTCs a single fire engine response standard



#### **Proposal for change:**

• To be more consistent and align to the DCLG definition of a response standard, the response standard should measure the attendance of the first fire engine to arrive at an incident



- RBFRS will still send more than one fire engine including specialist support vehicles if the nature of the incident requires them. These are set by our **pre-determined attendances**, which designate the number of fire engines for each scenario.
- A single fire engine response standard applied to all incidents is more consistent and therefore, easier to understand than a number of multi-fire engine standards.
- It aligns RBFRS to the national DCLG definition of a response standard.

• Second and additional fire engine targets will be monitored internally.

# Proposal 4: How should we express the reporting of our response standards?

#### What we do currently:

• Our internal performance monitoring systems measure the attendance times of the fire engines for each station. This tells us when we have not met our expected attendance times




<u>Or</u>

#### **Option for change:**

- The response standard would be published as a **target** percentage, as this would create a more transparent and measurable reporting response standard
- This would be expressed as:

"We will target our operational response activities to arrive at incidents within 'X' minutes on 'Y' % of occasions."



- Publishing a target percentage provides transparent information for the public.
- Publishing a target percentage provides a clear measurable reporting standard for the public.
- By publishing a percentage target, <u>we are not changing our station</u> locations, the number of fire engines and how they are crewed.
- The tables below are based on our existing community risk management arrangements and shows our current response times (based on previous performance data from 2012-2014) across a range of times for the first fire engine arriving at dwelling fires and road traffic collisions.

Time for 1 <sup>st</sup> fire engine to dwelling fire (in minutes)	8	9	10	11	12
How often we make this time (%)	60%	70%	77%	82%	85%

Time for 1 <sup>st</sup> fire engine to Road Traffic Collisions (in minutes)	8	9	10	11	12
How often we make this time (%)	43%	52%	60%	68%	75%

\* Tables relate to current attendance times plus an average call handling time of 90 seconds

• The table below is based on our existing community risk management arrangements and shows our predicted response times (based on previous performance data from 2012-2014) across a range of times for the first fire engine arriving at all incident types.

Time for 1 <sup>st</sup> fire engine to all incident types (in minutes)	8	9	10	11	12
How often we make this time (%)	55%	65%	75%	80%	85%

\* Table relates to current attendance times plus an average call handling time of 90 seconds

- By expressing the standard in this way we can clearly report our ongoing performance, and show any impacts and benefits future changes may have to our service based on our modelling data.
- The table above shows that whichever number and percentage is used, you will always get a fire engine when you need one. The variation in times is due to a number of factors that can include incidents in remote or rural areas, traffic congestion, difficult access, etc.

We value your feedback about these proposed changes to how we currently define and report our response standards. We also want to hear your view and ideas through this consultation about whether there is anything else we should consider in relation to these matters.

## 7. Next Steps

This consultation is part of the ongoing process of how we manage community risk in Royal Berkshire. The next stage in this process will be to develop the four key projects outlined in the Integrated Risk Management Plan 2015-19 and will look at some fundamental aspects of our service, including station locations, numbers of fire engines and shift patterns. These options will need to enable Royal Berkshire Fire Authority to balance its budget for the 2015-19 period.

#### Introduction to New Grounds Maintenance Service

Our new grounds maintenance contract with ISS Facility Services Landscaping is focussed on clear outcomes, which means an end to the "one-size-fits-all" approach of previous years. We are setting out clear objectives as to what this partnership will deliver. We have made a significant step forward in creating some challenging (although achievable) KPI's (Key Performance Indicators). We have moved away from frequencies and dates for programmed works and shall instead focus our resources to where it is most needed, based on clear outcomes. Our new approach is in its early days, and we are constantly reviewing and managing how our partnership with ISS is performing. We will be looking at customer concerns and responding where they are legitimate as we move through our first growing season under this new system.

The most significant and obvious change relates to grass cutting, as follows;

#### Long Grass

Grass cutting will become far more targeted, and leads on something which we started last year;

- Large highway verges in both rural and urban areas will be left to establish into grassland habitats, but with grass cut regularly around the fringes to ensure grass doesn't encroach onto pathways, roads or obstruct sight lines.
- Areas in our large parks will have increased areas of grassland with wide mown footpaths through them, similar to Cantley Park and Ashenbury Park last year.
- In smaller parks where there are woodland areas will we allow margins of grassland to develop instead of cutting right up to the park boundary.
- We will avoid cutting grass right up to the bases of trees and instead allow the grass to grow.
- The time saved will be used to focus on maintaining regular mown areas to a higher standard than the past, mainly sports pitches, play areas, cemeteries and other high use sites.

#### Wildflowers

In 2015 we experimented with 13 different wildflower seed mixes. This was a proven success introducing a variety of wildlife habits and improving the look of several areas across the borough.

- In 2016 you will continue to find wildflowers at Ashenbury Park (Woodley), Cantley Parkland (Wokingham), the Woosehill Spine Road, Winnersh Meadows and some highway verges across the borough.
- From 2017 we will start to increase the presence of wildflowers at selective sites by 10,000sq/m per year for 10 years.

#### Why is this happening?

- The National Pollinator Strategy details the decline of pollinating insects over the past 70 years, and offers some insight in reversing this trend which includes allowing grass and wildflowers to grow and complete lifecycles. This is especially important in more urban areas.
- Biodiversity 2020 also provides information relating to the decline of pollinators
- WBC held a consultation with our residents on the back of a difficult grass cutting season in 2014. This clearly identified that there should be greater attention given to high use sites which includes sports pitches and play areas.
- 2015 proved, through numerous compliments during our limited trial, how well received this change in approach has been and we decided to build on this positivity for 2016.

#### Ongoing monitoring and review

- We are aligning ourselves with various projects across the country, endorsed by many plant life organisations including; RHS, BBC Countryfile & Gardener's World, CPRE, Kew Gardens, Alan Titchmarsh's Road Verge Campaign etc.
- We will have experts from Reading University assess the sites for biodiversity throughout the year to inform future plans, which we hope to share at various forums.
- We hope to see a marked increase in pollinators together with an increase in flower-rich grasslands.
- Performance Officers will make regular checks across the borough to ensure we are striking the right balance of increased grassland areas and increasing the quality of mown grass sites.
- We will maintain a flexible approach to this, and where there is a genuine example of limited recreational access to green space we will ensure that this is rectified.
